## INTERVIEW AND TRIBUTE

### Sheila Brush, LLC's President during Three Years of Renewal and Change.



Sheila has served LLC as president since June 1, 2023. This June 1, 2026, she will step away from the presidency. During her three-year term, she faced daunting challenges. By the fall of 2023, LLC had returned to holding in-person classes, but the lingering COVID-19 epidemic still gave many members realistic concerns about on-site classes. LLC needed to rethink the kinds and balance of classes it would offer as well as come to terms with new technology. Then suddenly in 2024-2025, LLC needed to find a new home. In this interview, Sheila shares her thoughts on these and other events.

#### What motivated you to take the presidency?

"In 2015, I retired and I found that LLC with its diversity of courses and with its lively members enriched my and my husband's retirement. And, as a member, I was so proud of LLC's response when Covid turned our world upside down."

Indeed, quarantine restrictions on face-to-face meetings started two weeks after the beginning of the spring 2019 semester. LLC immediately cancelled classes at Temple Beth El, but we did not stop learning. As Sheila recalls, "Our leadership shifted us to Zoom on a dime. Some key volunteers helped members master this new approach to learning. And our members stepped up to the challenge. They showed they were not afraid of technology."-Many times, I have heard members say that LLC was their lifeline during Covid.

Sheila continues, "So, when LLC put out a call in 2023 for people interested in becoming President, I felt that this was an opportunity to give back to the organization that I loved and enjoyed so much. I felt I had the experience needed. I had worked for many years with non-profits. For example, I helped to found Grow Smart RI (a non-profit started in 1991, dedicated to helping RI develop economically and in a sustainable manner while

preserving our quality of life and place). At Grow Smart, I gained a lot of experience in bringing together people with different interests to achieve common goals.”

**What have been the highlights of your presidency?**

“In the fall of 2023 we held our first in-person convocation in three years and celebrated LLC’s 40<sup>th</sup> anniversary. As we prepared for that, I had a chance to learn more about LLC’s beginnings from long-time members and past leaders and to understand the effort and thought that had gone into founding LLC. That was very inspiring. Then Art Norwalk, our Marketing Chair, made a wonderful video that gives us all a sense of LLC during the early years and of LLC, generally.

“In 2023, I worked closely with Planning Committee Co-Chairs Nick Miles and Dennis Flavin and the Planning Committee to produce a three-year strategic plan for LLC.” That plan, it should be noted, challenged each of LLC’s committees to do a self-evaluation of their routine orders of business and to come up with milestones and operational goals for the next three years. It was LLC’s first strategic plan and it still guides the work of our committees.

*“Sheila has accomplished so much during her tenure—from moving us to a new home base to shepherding the development of a strategic plan. And that’s just the tip of the iceberg. Even more important, she has done it with aplomb and a style that’s been warm, welcoming, and inclusive. Presidential success has become a pejorative term these days. But not with Sheila. LLC has thrived under her leadership.”*

Another very bright highlight of Sheila’s three years as president was this spring’s convocation. “I had felt that we could do more to enliven our convocations.” Indeed, she did more.

“In the fall of 2025,” Sheila explains, “we were approached by leaders of Edgewood Village to join forces and create a program together.” Their idea was to bring the well-known actor Peter Gerety to speak and reminisce. Gerety had grown up in Edgewood and gotten his start in acting by joining the then young and experimentally-oriented Trinity Square Repertory Company. He had many tales to tell, and he loved to tell them. Sheila and the Edgewood leaders formed a planning committee and came up with the idea of having Tony Estrella, the Gamm Theater’s Artistic Director, interview Gerety. Then they set about integrating the interview with LLC’s usual convocation events, including the Coordinators Open House.

The event was a huge success, with more than 200 attendees, most of them LLC'ers. Sheila adds, "This event offered LLC a chance to collaborate with Edgewood Village and to change spring convocation. I was delighted with the response of the neighborhood and with LLC members. We learned a lot about how to collaborate with another organization and established a great relationship with Edgewood Village."

### **The move to the Shriner's Center and its impact**

Perhaps the most prominent event of Sheila's presidency, and the biggest challenge to her leadership, was LLC's move from Temple Beth El to the Shriners Center. It was a daunting challenge that came on suddenly.

In 2024-2025, Beth El's administrative leadership suddenly made new demands on LLC, to impose fee increases, and to suggest plainly that LLC should look for a new home. In response, Governance Co-Chair Dave Hansen and Treasurer Gene Mihaly began a search for new space for our classes. Luckily, just as our lease with Beth El was expiring, we received word that the Shriners Center might have classroom space available, plus it had a large, mostly empty parking lot. These features were powerful selling points. After careful review by the Board, a lease with the Shriners was approved and signed. *But that was only the beginning.*

Now the work of the move really began, and Sheila paid attention to every detail and demand. The membership had to be helped to understand that the move was necessary and that the new location was an excellent choice. Sheila led the way in communicating so effectively with the membership. Then, all the details that go into moving our furniture, technology and other properties demanded attention, and Sheila paid attention. She was there on pack-up day, on moving day, and on many days after that. She drew to-scale floor plans for tables, chairs and TV carts, making sure that each classroom would be ready for the start of classes in fall 2025. Then she made sure that at convocation and other times, the membership could tour the new facilities and be ready for start of classes on September 15, 2025.

The impact of the move to the Shriners Center remains a concern for Sheila and for LLC. Sheila and the Board have closely monitored the situation. "Our membership numbers are pretty much the same as in past years. The number of seats filled in classes is pretty much the same, too. Many people like our new home. Everyone agrees that the parking is great, and we have an opportunity to attract more members from South County and West Bay." But what about the membership from the East Bay? "For us to know the true impact of the move, we'll need to look at membership numbers after our new membership year begins in June. We should probably do a survey to better understand the issues the move has created for some members. Then, once we get the results, we will have to decide what can be done to respond to those issues. Unfortunately, what we can't do is speed up the Bridge repairs!"

### **Looking to the future for LLC and for herself**

"I'm very enthusiastic about LLC's future. We have a strong organization with very strong leadership. We are close to what I think may be our membership level sweet spot for the next few years of about 550 members. I'm excited about the opportunity technology offers for hybrid classes. We have enthusiastic members. They help spread the word so that others become interested in what we have to offer. Many already serve as coordinators and work on committees, and I think there are many more members who are ready to get involved in helping our all-volunteer organization flourish. And we have the invaluable support of our Administrator Merrie Lavigne."

*For the past three years, Sheila has been totally committed to ensuring the ongoing success of LLC. She was a driving force in the transition to our new home at Shriners, an enthusiastic supporter of (and activist in implementing) the strategic plan as well as a direct participant in so many programs and activities. Her well organized, thorough, and hands-on leadership inspired many others to become more involved.*

In thinking about the future of LLC, Sheila has wise words of advice, based on the retirement trends among potential new members. "There has been a shift in the retirement age. People are retiring later, in their early 70's and older. If we are going to keep up our membership numbers, we need to attract that age group." Sheila asks, "Can we effectively attract 70-year-olds? We need to let them know what LLC has to offer them. Maybe we should start talking with university HR departments and with teacher unions to let them know about LLC just as they are retiring. Maybe we could get our name into their retirement packets."

What will Sheila do, starting in June, when she steps down from the presidency? “I'm looking forward to getting back to coordinating! And I'm sure I'll work on an LLC committee because I love working with other members.” On a personal note, Sheila explains, “During these past three years, my husband Dick (Sheila’s husband, former LLC Treasurer, and active LLC member) has been so supportive. Now we're looking forward to having more free time for trips, theater and the other activities we enjoy together. And, of course, our grandchildren—if busy teens have time for their grandparents!”

This semester, Gayle Gifford and Cathy Hurst have been co-coordinating an LLC course entitled: "Explore Providence's Public Art, Meet Jane Jacobs, and Co-Lead a Walking Conversation."

Named after urban activist and writer [Jane Jacobs](#), Jane's Walks are held annually during the first weekend in May to coincide with her birthday, May 4. Jane's Walks take place in hundreds of cities each year. They are walking conversations and create space for civic dialogue and neighborhood pride. They are led by anyone who has an interest in the neighborhood where they live, work, play, or socialize.
